RESULT

The Haryana Public Service Commission has finalized the result for recommendation of the candidates to the posts of HCS (Ex. Br.) and other Allied Services on the basis of Main Written Examination held on 12.08.2023 & 13.08.2023 and the Interview/ Personality Test held from 09.10.2023 to 11.10.2023, against Advt. No. 11/2023 dated 09.02.2023, followed by corrigendum dated 07.03.2023.
